

Massachusetts Medical INSURANCE INFORMATION

As of Jan 1, 2005

***If you want your insurance company to cover the initial visit please make sure you have a referral if you have a managed care plan. You must find out how much is your co-payment and deductible.***

**Fallon Community Health Plan**

Dr. Lockerman is an in-plan provider (Provider number: 14282)  
For an initial visit your primary care physician has to fax the pre-authorization form to Fallon, and Fallon has to fax the approved authorization to us before the appointment can be scheduled

**CIGNA Healthsource-CMHC (Massachusetts only)**

Dr. Lockerman is in-plan provider for the Massachusetts plan, Provider # 35432. For all other CIGNA plans Dr. Lockerman is an out of plan provider. For an initial visit your primary care physician has to fax the referral form to us before the appointment can be scheduled

**Tufts Health Plan**

Dr. Lockerman is a out of plan provider (Provider # 729583)  
For an initial visit your primary care physician has to fax the OUT of PLAN written (SIGNED BY A TUFTS REVIEWER) referral form to us before the appointment can be scheduled, the referral form must be signed by Tufts reviewer, this is not a guarantee of coverage, Approval does not mean they will pay for visit.

**Blue Cross and Blue Shield of Massachusetts (Provider number: 000X06938)**

If you have a managed care plan that need referrals to see a specialist you will need a referral to see Dr. Lockerman from your primary care physician for the initial visit. *Primary care physician has to call Blue Cross by phone to get a referral number.*

**HMO Blue (Masachusetts)** plans will cover an initial visit. Your primary care physician must get a referral number. Dr Lockerman is not listed in POS system, *your PCP must make a phone call to Blue Cross to get the referral number.* The referral number has to be called in or faxed to Dr. Lockerman's office. If your doctor's office is having problems getting the referral, have them call our office (800)259-0952 and speak with our office manager.

**PPO Plans:** *Patients have to call Blue Cross to find out if the initial visit is covered and how much is the deductible. NO referral is needed.*

**GIC Indemnity (Massachusetts),**

No referral is needed, you have to call your insurance plan to find out how much is the co-payment and deductible

**Harvard Pilgram Health Plan-(HPHC)**

Dr. Lockerman is an *in-plan provider* (provider number: 381352)  
For an initial visit your primary care physician has to register the referral in the HPHC computer system. Please give us the referral number when you schedule your initial visit.

**Neighborhood Health Plan,** out of network provider, provider # 28169

**Medicare** does not cover most visits. Dr. Lockerman does not have a Medicare provider number in Massachusetts.
